### **FY 2019 Historic Preservation Fund Grant Applications Now Available**

Applications and instructions for the FY 2019 federal Historic Preservation Fund sub grants are available at <https://scdah.sc.gov/historic-preservation/programs/grants>. Administered by the SHPO, these matching grants can assist two types of projects:

- ***Survey and Planning Projects***—eligible projects include surveys of historic properties, National Register nominations, preservation education, and preservation planning.
- ***Stabilization Projects***—eligible projects include stabilizing historic buildings or protecting historic buildings from the adverse effects of the weather. Stabilization Projects are limited to projects located in South Carolina's [Certified Local Government \(CLG\) communities](#).

Any local government, non-profit, or institution in South Carolina may apply for a Survey and Planning Project. Local governments, non-profits and institutions located in a CLG community may also apply for a Stabilization Project. At least ten percent of the state's annual allocation from the National Park Service must be awarded to CLGs. Grant awards generally range from \$1,500 to \$25,000. **Applications will be accepted until 5:00 PM, on Thursday, May 2, 2019.** Please contact Brad Sauls at 803-896-6172, or [bsauls@scdah.sc.gov](mailto:bsauls@scdah.sc.gov) to discuss your project before you apply.


### 2019 Statewide Historic Preservation Awards Nominations Sought

### Tax Credit Spotlight

This month's spotlight is the Waikiki Village Motel in Myrtle Beach, which was constructed in 1963 by S.M. Johnston. The two-story, L-shaped building still reflects much of its original design and is one of few remaining examples of Mid-Century Modern architecture in Myrtle Beach. It is constructed of steel, brick, concrete and glass and features bright colors, a Hawaiian-style hut which serves as the hotel lobby, and a courtyard with a kidney-shaped pool. The hut is the focal point of the site with overhanging eaves, storefront and a pyramidal capstone asphalt shingled roof. The rehabilitation of Waikiki Village Motel included restoration of the hut's exterior to the original appearance, repairs to the original windows and doors, painting of the opaque panels, upgrades to mechanical systems, and restoration of the existing terrazzo floors. The landscape was restored to the original design which included retaining the kidney shaped pool in place. The rehabilitation of the Waikiki Village Motel was completed in 2018 with the use of the federal and state income-producing tax credits with a private investment cost of approximately \$1.6 million.

## Grant Application Deadlines

**April 1, 2019 Historic Revitalization Subgrant Program (HRSP)**. The National Park Service is accepting applications for \$5 million in grants to support the preservation of historic buildings in rural communities across the country that are listed in or eligible for listing in the National Register of Historic Places. Eligible primary recipients are State Historic Preservation Offices, Tribal Historic Preservation Offices, Certified Local Governments, and non-profits able to support a competitive subgrant program. All applications are due through [grants.gov](https://www.nps.gov/orgs/1623/historic-revitalization-subgrant-program.htm) under opportunity number P19AS00015 by 11:59 PM on April 1, 2019. **April 8, 2019 Battlefield Preservation Planning Grants.** These grants fund a wide range of activities, including historical research, archaeological surveys, site documentation, education, interpretation, heritage tourism and economic impact studies, strategic and preservation planning, public outreach, and consensus building. Planning activities that may enhance a battlefield in or adjacent to a municipality may be eligible for funding. Nonprofit organizations, educational institutions, and federal, state, tribal, and local governments can apply. No matching funds are required.
