Tax Credit Spotlight

This month's spotlight features a ca. 1890, two-story, masonry commercial structure located in the Anderson Downtown Historic District. This store building is a contributing resource to the National Register historic district and is typical of commercial structures east and west of the Courthouse Square constructed during the late-19th century's transition from wood-frame to masonry structures. During the 20th century, the late-Victorian detailing of the façade, notably the storefront and windows, were removed. With a private investment of nearly \$700,000 and federal and state income-producing tax credits, the façade was restored and the interior was rehabilitated with a boutique wedding planner on the ground level and a co-working space on the upper floor. The scope of work included restoring the façade based on historic documentation, repointing with compatible mortar, sensitively upgrading the HVAC and electrical and adding fire suppression, restoring the interior plaster, retaining and restoring the historic bead board ceiling and trim, restoring the hardwood flooring, retaining historic interior doors and designing compatible replacement doors where missing, preserving the historic skylight, and preserving the historic character of the interior layout while rehabilitating the building for new uses. ### State Constitutions Exhibit at the Department of Archives & History

"All Political Power is Vested in and Derived from the People" The Constitutions of South Carolina is an exhibit of the recently conserved South Carolina Constitutions of 1776, 1778, 1790, 1861, 1865, 1868, and 1895. This is a rare opportunity to view the Constitutions of South Carolina. It is the first time these foundational documents have been displayed together for public viewing. Also on display is South Carolina's 1682 recorded copy of the Fundamental Constitution of Carolina. The free exhibit is at the South Carolina Archives & History Center at 8301 Parklane Road in Columbia. It is open Monday — Saturday 8:30 A.M. — 5:00 P.M. (On Saturdays the building closes from Noon — 1:00 P.M. for lunch).

Two SC Sites to be Added to Brown v. Board of Education National Historical Park

The National Park Service <u>recently announced</u> a law to expand and redesignate the Brown v. Board of Education National Historical Park was signed by President Biden. The law added two school sites in South Carolina to the historical park upon acquisition by the National Park Service (NPS), and designates schools in Delaware, Virginia and the District of Columbia as affiliated areas of the NPS. The authorized additions to the park are:

- Summerton High School (Summerton, SC). Built in 1936 and listed on the National Register of Historic Places, Summerton High School was an all-white school that refused to admit black students prompting the *Briggs v. Elliott* case.
- Scott's Branch High School (Summerton, SC). The former "equalization school" was constructed for African American students in 1951 under the guise of providing facilities comparable to those for white students. Today, the former school is now the Community Resource Center owned by Clarendon School District 1.

The Woodland Cemetery and African American Burial Ground Historic Preservation Project and the Legacy Council at Clemson University have issued a call for paper proposals for the second annual Research Symposium to be held October 24-25, 2022 at Clemson University. This year's theme, "Historic Cemeteries in Cultural Contexts, Local to Global," encompasses the broadest conception of burial grounds, from local cemeteries to shipwrecks on the seafloor. They seek proposals from the public, professionals, scholars, and graduate students of all disciplines who are working to research, publicize, and/or memorialize historic cemeteries and burial grounds. #### Grant Application Deadlines

NEW August 10, 2022 Underrepresented Communities Grant. The National Park Service's Underrepresented Communities Grant Program (URC) is now accepting applications. Projects include surveys and inventories of historic properties associated with communities underrepresented in the National Register of Historic Places, as well as the development of nominations to the National Register for specific sites. All projects must result in the submission of a new nomination to the National Register or National Historic Landmark Program, or an amendment to an existing nomination to include underrepresented communities. Grants are awarded through a competitive process and do not require non-Federal match. Eligible applicants include: State Historic Preservation Offices (SHPOs); Indian Tribes that meet the definition in 54 USC 300309 and Native Hawaiian Organizations that meet the definition in 54 USC 300314; and Certified Local Governments (CLG). Monthly, SC Humanities Council Mini Grants. SC Humanities awards Mini Grants to support public humanities programs of modest cost, with awards of \$2,000 or less. Monthly, SC Humanities Council Planning Grants. SC Humanities awards Planning Grants to support preliminary work in designing a project that warrants detailed planning because of its length, scope, or cost. Awards are \$2,000 or less. Open for Applications, USDA - Rural Development Community Facilities Direct Loan & Grants. This program provides affordable funding to develop essential community facilities in rural areas.
