#### **Disaster Recovery Information**

Please use the <u>Hurricane Damage Report for Historic Properties form</u> to help the South Carolina State Historic Preservation Office assess the extent of damage to historic properties by wind and flooding associated with recent hurricanes. Historic properties are buildings, structures, objects, sites, and districts listed in or eligible for listing in the National Register of Historic Places. Please check the National Register status of the reported property on <u>SC ArchSite</u>, our online GIS. The form is ONLY to report on historic properties to aid the SHPO in organizing our response. This form is NOT for insurance claims or requests for public aid. This form is likewise NOT for requests for immediate life or death public assistance.

Funding Alert: Fall Grant Cycle Anticipated for Historic Properties Damaged by Hurricane Irma in September 2017

For historic properties damaged by last year's hurricanes (Harvey, Irma, and Maria), Congress appropriated \$50 million for historic preservation projects to be administered by State Historic Preservation Offices in affected states and territories, including South Carolina. The SC SHPO has applied to the National Park Service (NPS) for the funding allocated for South Carolina, and if approved, anticipates running a grant application cycle in October/November to select projects for funding. Projects must fund repairs to historic properties (listed in or eligible for listing in the National Register of Historic Places)

caused by Hurricane Irma. As required by NPS, grant projects must follow state procurement requirements, and meet the appropriate Secretary of the Interior's Treatment standards. Matching funds are not required. Additional information will be posted on our website as it becomes available, and will be announced in agency social media and this newsletter. It is unknown at this time whether similar funding will be available in the future for damage being caused by Hurricane Florence.

### **Updated State Tax Credit Application Forms**

The 25% Homeowner tax credit application forms have been updated to make it easier for applicants to quickly and accurately complete tax credit applications. The revised application forms feature fillable fields except where original signatures are required. The application forms have also been revised to include 'pop-up' information boxes. Wherever a blue information circle is present, the applicant can click the "i" to bring up an information box which provides additional information and FAQ's about that section of the application. Previously, the application instructions, sample applications, and additional resources like *Tips for Approval of Proposed Work, Tips for Taking Photographs,* and *Tips for Writing Architectural Descriptions* were separate documents. We have combined these documents into one Application Instructions packet to make these helpful resources easier to find and utilize. #### National Preservation Institute Seminar Coming to Columbia in December

A two-day seminar "The Secretary of the Interior's Standards: Treatment Considerations" is scheduled for Columbia December 5-6, 2018. The Standards form the basis for historic property rehabilitation for all federal undertakings, for federal tax benefits, and often for state, local, and private projects. The seminar will focus on the preservation of historic fabric, sustainable strategies, energy conservation, accessibility considerations, health and safety codes, security issues, and climate change. # Three SC Colleges Receive Preservation Grants

On September 6, the National Park Service awarded \$8.6 million in grant funding toward projects that preserve significant historic structures on the campuses of 18 Historically Black Colleges and Universities (HBCUs), including South Carolina State University for Wilkinson Hall, Vorhees College for Booker T. Washington Hall, and Benedict College for Morgan Hall. HBCU Grants support preservation of sites that are listed in the National Register of Historic Places. Read more about the grants here.

### **Grant Application Deadlines**

October 8, 2018 African American Civil Rights Grants. The National Park Service's State, Tribal, Local, Plans & Grants Division is now accepting applications for \$13 million in funding for the 2018 African American Civil Rights (AACR) grant program. These competitive grants support the survey, documentation, interpretation, and preservation of sites that are associated with the African American struggle to gain equal rights in the 20th century. Eligible applicants are Federally Recognized Indian Tribes, Alaska Natives, Native Hawaiian Organizations, States and Territories, Local Governments, and nonprofit organizations. Matching funds are not required, but may be considered as part of the evaluation process. Types of eligible projects include survey, inventory, documentation, interpretation, education, architectural services, historic structure reports, preservation plans, and physical preservation projects. To apply, go to grants.gov and search for Funding Opportunity Numbers: P18AS00485 for Preservation projects, P18AS00484 for History projects, or African American Civil Rights (AACR) Grants. NEW November 1, 2018 Underrepresented Community (URC) Grants. The NPS State, Tribal, Local, Plans & Grants Division is accepting applications for \$500,000 in funding for the URC grant program. These competitive grants work towards diversifying the nominations submitted to the National Register of Historic Places. Eligible applicants are Federally Recognized Indian Tribes, Alaska Natives, Native Hawaiian Organizations, States and Territories, and Certified Local Governments. Types of eligible projects include surveys and inventories of historic properties associated with communities underrepresented in the National Register, as well as the development of nominations to the National Register for specific sites.
