State Board of Review Approves 6 Nominations to the National Register of Historic Places

The State Board of Review for the National Register of Historic Places met Friday, March 25, 2022 at the SC Archives & History Center in Columbia and approved the following nominations:

- Abbeville County Training School, Abbeville, Abbeville County
- Allendale Training School, Allendale, Allendale County
- Clarendon County Health Center and Office Building, Manning, Clarendon County
- Greer Mill, Greer, Greenville County
- Horry County Courthouse, Conway, Horry County
- Ellen Dean Hotel, Lancaster, Lancaster County

The nominations have been forwarded to the Keeper of the National Register at the National Park Service in Washington, DC who makes the final decision about listing the property in the National Register. Tax Credit Spotlight

Located within the Hampton Park Terrace National Register historic district in Charleston, this month's spotlight is a one-story Minimal Traditional house built around 1930. Between 2021 and 2022, the current owners applied for the 25% State Historic Rehabilitation Tax Credit. The SHPO approved proposed rehabilitation work which included masonry repairs; structural repairs; in-kind roof replacement; compatible dormer addition; repairs to windows and doors; restoration of historic plaster; alterations to secondary spaces; upgrades to MEP; and rehabilitation of a historic outbuilding. This rehabilitation balanced a project with a wide scope of work and met the Secretary of the Interior's Standards for Rehabilitation. In 2022, the SHPO certified the completed work, earning the current owners the state income tax credit equal to 25% of eligible rehabilitation

expenses. The property owner, Anne Kelley Russell, highlights the benefits of the historic rehabilitation tax credit: "We view the historic tax credit as a lovely way to recognize our commitment to preserving our home and our historic neighborhood. Chris Tenny and other members of the State Historic Preservation Office were incredibly helpful in guiding us through the process and gave us additional ideas of ways we could better preserve our home. We are proud of what we have accomplished and are thankful for the historic tax credit program." State Constitutions Exhibit at the Department of Archives & History

"All Political Power is Vested in and Derived from the People" *The Constitutions of South Carolina* is an exhibit of the recently conserved South Carolina Constitutions of 1776, 1778, 1790, 1861, 1865, 1868, and 1895. This is a rare opportunity to view the Constitutions of South Carolina. It is the first time these foundational documents have been displayed together for public viewing. Also on display is South Carolina's 1682 recorded

copy of the Fundamental Constitution of Carolina. The free exhibit is at the South Carolina Archives and History Center at 8301 Parklane Road in Columbia. It is open Monday – Saturday 8:30 A.M. – 5:00 P.M. (On Saturdays the building closes from Noon – 1:00 P.M. for lunch).

American Revolution 250th Anniversary Commission Grant Program & County 250 Committee Initiative

South Carolina played a major role in the birthing of America 250 years ago. The South Carolina American Revolution Sestercentennial Commission (SC250) was created by the Governor and State Legislature in 2019 to help SC prepare for the many anniversaries of the Revolutionary Era (1770-1783 | 2020-2033). The SC250 Commission is encouraging each county to have one official County 250 Committee to help celebrate the people, places, principles, and events from each community. To help each county get started, SC250 has just launched the County 250 Organizing Grants. These non-competitive grants offer \$3,000 per county to aid in creating an "official" County 250 Committee and kick-starting the group's activities. Plus, eight more grant programs are yet to come, covering everything from County Asset Assessment & Tourism Planning to Site Acquisition to Museum Style Panels. Grant Application Deadlines

April 28, 2022 FY22 Historic Preservation Fund Grants. Applications and instructions for the FY22 Historic Preservation Grants are available at <https://scdah.sc.gov/historic-preservation/programs/grants>. Administered by the SHPO, the matching grants can assist two types of projects: Survey and Planning and Stabilization. Any local government, non-profit, or institution in South Carolina may apply for a Survey and Planning Project. Local governments, non-profits and institutions located in a CLG community may also apply for a Stabilization Project. At least ten percent of the state's annual allocation from the National Park Service must be awarded to CLGs. Grant awards generally range from \$2,500 to \$35,000. Monthly, SC Humanities Council Mini Grants. SC Humanities awards Mini Grants to support public humanities programs of modest cost, with awards of \$2,000 or less. Monthly, SC Humanities Council Planning Grants. SC Humanities awards Planning Grants to support preliminary work in designing a project that warrants detailed planning because of its length, scope, or cost. Awards are \$2,000 or less. Open for Applications, USDA - Rural Development Community Facilities Direct Loan & Grants. This program provides affordable funding to develop essential community facilities in rural areas. An essential community facility is defined as a facility that provides an essential service to the local community for the orderly development of the community in a primarily rural area.
