Reminder: 2023 South Carolina Historic Preservation Conference Proposals Due December 16

We are accepting proposals for Educational Sessions for the 2023 conference to be held on April 28, 2023 at the SC Archives & History Center. Educational Sessions can cover a variety of topics and range in difficulty from "Preservation 101" to discussions of emerging issues. Historic Preservation State Grant Fund Applications Due January 31, 2023

The South Carolina Department of Archives & History is accepting applications for the new Historic Preservation State Grant Fund. The purpose of the State Grant Fund is to support historic preservation projects that benefit local communities through the physical repair and rehabilitation of South Carolina's historic buildings. Eligible applicants are nonprofit organizations and institutions, local governments, and federal or state recognized Native American tribes.

Grants ranging from \$40,000 to \$200,000 will be awarded for the stabilization and weatherization of historic buildings. A minimum 20% cash match of the Total Project Cost is required. Buildings must be listed as a

contributing resource in a National Register of Historic Places historic district or individually listed in or eligible for listing in the National Register of Historic Places. Project work must meet the <u>Secretary of the Interior's Standards for Rehabilitation</u>. The application deadline for the 2023 applications is 5:00 PM on January 31, 2023. State Board of Review Approves 8 Nominations to the National Register of Historic Places

The State Board of Review for the National Register of Historic Places met on Friday, November 18, 2022 at the SC Archives & History Center in Columbia and approved the following nominations:

- Lady's Island Bridge, Beaufort, Beaufort County
- Peachtree Plantation, McClellanville vicinity, Charleston County
- Phillips Community Historic District, Mount Pleasant, Charleston County
- Camden Battlefield (Additional Documentation), Camden vicinity, Kershaw County
- Peter M. and Alice Oliver House, Swansea, Lexington County
- Lakeview School, West Columbia, Lexington County
- Chapel of Hope, Columbia, Richland County
- Startex Finishing Company, Startex (Wellford and vicinity), Spartanburg County

The nominations will be forwarded to the Keeper of the National Register at the National Park Service in Washington, DC who makes the final decision about listing the property in the National Register. Tax Credit Spotlight

This month's spotlight features a hipped-roof, masonry building in the Charleston Historic District along East Bay Street built around 1781 as a three-story wharf building and altered in the mid-19th century to its current two-story configuration. In the late 20th century, the building was converted to its present use as a residence. In 2021, property owner Eric Nofzinger, earned the homeowner historic rehabilitation tax credit for eligible rehabilitations expenses. He noted the importance of the incentive stating, "The Tax Credit program from the State of South Carolina was critical to enable the work required to preserve this historic structure for generations of South Carolinians and tourists from around the globe." The rehabilitation included stabilizing the deteriorated roof truss system by sistering wood, steel, and modern strapping to the historic timbers without replacing any of them; stabilizing the exterior wall system by temporarily and prudently removing the storefront brackets to secure tie-rods between the 2nd level floor joists and the wall system; carefully removing failed mortar and stucco without damaging the historic brick and then repointing and rendering the building with physically and visually compatible mortar and stucco colored with permeable mineral paints; replacing the west elevation's non-historic primary door with a more appropriate transom and paneled door; and replacing non-historic window shutters with more appropriate louvered and paneled shutters. Grant Application Deadlines

NEW December 19, 2022 Conserving Black Modernism Grant. The African American Cultural Heritage Action Fund in partnership with the Getty Foundation has created this new grant program to provide funding and technical support to preserve the material heritage, innovation, and legacy of modern architectural sites designed by Black architects. December 20, 2022 Save America's Treasures (SAT) Grant Program The National Park Service is now accepting applications for the SAT program, which provides preservation and conservation assistance to nationally significant historic sites and collections. \$26.5 million will be competitively awarded. A dollar-for-dollar, non-Federal match, is required which can be either cash or documented in-kind services. SAT is administered by the National Park Service (NPS) in partnership with the National Endowment for the Arts (NEA), the National Endowment for the Humanities (NEH), and the Institute of Museum and Library Services (IMLS). Preservation

projects fund physical preservation of historic buildings, sites, structures, and objects. Collection projects include conservation of artifacts, museum collections, documents, sculptures, and works of art. Applications are due December 20, 2022. To apply for funding for Preservation projects go to opportunity number P22AS00432 To apply for funding for Collections projects go to opportunity number is P22AS00433. January 10, 2023 Historically Black Colleges & Universities Grant Program. The National Park Service is now accepting applications for the FY2022 Historically Black Colleges & Universities Grant Program (HBCU). HBCU competitive grants are funded by the Historic Preservation Fund (HPF), administered by the NPS, and fund a broad range of pre-preservation planning activities and physical preservation work for historic sites that are listed in or eligible for listing in the National Register of Historic Places or as a National Historic Landmark. Congress has appropriated \$10 million for the HBCU Grant Program. For more information and to apply visit Grants.gov: P22AS00384. Any accredited Historically Black Colleges & Universities are eligible to apply for funding. January 31, 2023 Historic Preservation State Grant Fund. Administered by the SC Department of Archives and History, this new state-funded grant program will award grants ranging from \$40,000 to \$200,000 for the stabilization and weatherization of historic buildings in South Carolina. Eligible applications are nonprofit organizations and institutions, local governments, and federal or state recognized Native American tribes. This fiscal year, SC250 also officially launches the following competitive grant programs: (click on the grant type for details): Museum Style Panel Grants, Local Activities Grants, <a href="County Asset Assessment & Tourism Plan Grants, Research Grants, Publication Grants, Signage & Marker Grants, Site Grants: Planning, Acquisition, Development, and Renovation. NEW February 7, 2023 Paul Bruhn Historic Revitalization Grant Program. The National Park Service is accepting applications for the FY2022 Paul Bruhn Revitalization Grants Program. The Bruhn program provides recipients (referred to as prime grantees) with a single grant that is then regranted in smaller amounts to individual projects (subgrants) in rural communities. Eligible applicants include nonprofit organizations, Certified Local Governments, State Historic Preservation Offices, and Tribal Historic Preservation Offices. Eligible subgrant properties must be listed in the National Register of Historic Places or determined eligible for listing, and must be located within rural (non-urban) communities with populations less than 50,000 according to the 2020 U.S. Census. Monthly, SC Humanities Council Mini Grants. SC Humanities awards Mini Grants to support public humanities programs of modest cost, with awards of \$2,500 or less. Monthly, SC Humanities Council Planning Grants. SC Humanities awards Planning Grants to support preliminary work in designing a project that warrants detailed planning because of its length, scope, or cost. Awards are \$2,500 or less. Open for Applications, USDA - Rural Development Community Facilities Direct Loan & Grants. This program provides affordable funding to develop essential community facilities in rural areas.
