Coming Soon: Electronic Submission of Federal Historic Tax Credit Applications

In the coming months, the National Park Service will require digital submission of the Historic Preservation Certification Application and all related documentation. The South Carolina SHPO will require project contacts or applicants to digitally submit HPCAs to our office through a web application called ShareBase. (Date of transition — to be determined). To facilitate this transition, SC SHPO will offer training for the required digital application submission procedures and other baseline documentation and description requirements for applications. Grant Application Deadlines

July 11, 2023 History of Equal Rights Grants Program. The National Park Service is now accepting applications for the History of Equal Rights (HER) grant program. Congress has appropriated \$5 million for the FY 2023 grants. Grant projects fund physical preservation or pre-preservation of sites associated with efforts to achieve equal rights. The History of Equal Rights grants are not limited to any specific group and are intended to include the broadest possible interpretation of equal rights for any American.

July 18, 2023 Underrepresented Communities Grants. The National Park Service's <u>Underrepresented</u>
Communities Grant Program (URC) is now accepting applications for FY2023 competitive grants. The National

Park Service's Underrepresented Communities Grant Program (URC) works towards diversifying the nominations submitted to the National Register of Historic Places. Projects include surveys and inventories of historic properties associated with communities underrepresented in the National Register, as well as the development of nominations to the National Register for specific sites. Congress has appropriated \$1.25 million for the 2023 URC Grant Program.

August 9, 2023 SC Humanities Major Grants. Major Grants (up to \$15,000 effective July 1, 2023) support public programs designed to be accessible by a broad audience, to serve citizens in urban, rural, and small-town settings, and to make possible humanities programs that illuminate and enrich the lives of both audiences and scholars. Monthly, SC Humanities Council Mini Grants. SC Humanities awards Mini Grants to support public humanities programs of modest cost, with awards of \$2,500 or less. (Starting July 1, the maximum amount will be \$5,000.) Applications are reviewed monthly with deadlines on the first business day of the month. Monthly, SC Humanities Council Planning Grants. SC Humanities awards Planning Grants to support preliminary work in designing a project that warrants detailed planning because of its length, scope, or cost. Awards are \$2,500 or less. (Starting July 1, the maximum amount will be \$5,000.) Planning Grants are reviewed monthly with deadlines on the first business day of the month.
