2024 South Carolina Historic Preservation Conference: Proposals Due December 15, 2023

We are accepting proposals for Educational Sessions for the 2024 conference to be held on April 26, 2024 at the SC Archives & History Center. Educational Sessions can cover a variety of historic preservation topics and range in difficulty from "Preservation 101" to discussions of emerging issues. Historic Preservation State Grant Fund: Applications Due December 31, 2023

The South Carolina Department of Archives & History is pleased to announce that the Historic Preservation State Grant Fund is accepting applications. The purpose of the State Grant Fund is to support historic preservation projects that benefit local communities through the physical repair and rehabilitation of South Carolina's historic buildings. Eligible applicants are nonprofit organizations [501(c)(3)], local governments, and federal or state recognized Native American tribes.

Grants ranging from \$40,000 to \$200,000 will be awarded to stabilization and weatherization projects of historic buildings. A minimum 20% cash match of the Total Project Cost is required. Buildings must be listed as a contributing resource in a National Register of Historic Places historic district or individually listed, or eligible for listing in the National Register of Historic Places. Project work must meet the [Secretary of the Interior's](#)

[Standards for Rehabilitation](#). The application deadline is December 31, 2023. To access the application and for additional information about grant requirements visit [this link](#).

State Board of Review Approves 4 Nominations

The State Board of Review for the National Register of Historic Places met on Friday, November 17, 2023 at the SC Archives & History Center in Columbia and approved the following four nominations:

- McGhee Block, Aiken, Aiken County
- McCormick County Office Building, McCormick, McCormick County
- Holly Hill Downtown Historic District, Holly Hill, Orangeburg County
- Augustus Belton and Margaret Wheeler Groce House, Lyman, Spartanburg County

The SHPO will forward the nominations to the Keeper of the National Register at the National Park Service in Washington, DC who makes the final decision about listing the properties in the National Register. Tax Credit Spotlight

This month's spotlight features a c. 1920 two-story, Colonial Revival residence in Greenville that is individually eligible for listing on the National Register of Historic Places for its locally significant Rustic architecture and construction method of facing the exterior with undressed rock. From 2020 to 2021, the homeowners completed a historic rehabilitation project that earned a state income tax credit equal to 25% of eligible expenses. The rehabilitation of the property included:

- gently cleaning the stonework;
- replacing the electrical wiring and HVAC system, wood siding deteriorated beyond repair in-kind, non-historic windows with more appropriate lite-patterns, and the deteriorated roof with a material compatible with the visual character of historic slate;
- repairing plaster wall finishes and historic windows and doors;
- restoring hardwood flooring, the east entry portico, the historic kitchen footprint, and fireplaces; and
- compatible site work.

December 19, 2023 Save America’s Treasures Grants. The National Park Service is accepting applications for the [Save America’s Treasures](#) (SAT) grant program. The SAT program provides preservation and conservation assistance to nationally significant historic sites and collections. \$26.5 million will be competitively awarded. A dollar-for-dollar, non-Federal match, is required, which can be either cash or documented in-kind services. SAT is administered by the National Park Service (NPS) in partnership with the [National Endowment for the Arts](#) (NEA), the [National Endowment for the Humanities](#) (NEH), and the [Institute of Museum and Library Services](#) (IMLS). Preservation projects fund physical preservation of historic buildings, sites, structures, and objects. Collection projects include conservation of artifacts, museum collections, documents, sculptures, and works of art. To apply for funding for preservation projects go to opportunity number P23AS00499. December 31, 2023 Historic Preservation State Grant Fund. Administered by the SC Department of Archives and History, the state-funded grant program will award grants ranging from \$40,000 to \$200,000 for the stabilization and weatherization of historic buildings in South Carolina. Eligible applications are nonprofit organizations, local governments, and federal or state recognized Native American tribes. A minimum 20% cash match of the Total Project Cost is required. Buildings must be listed as a contributing resource in a National Register of Historic Places historic district or individually listed in the National Register, or eligible for listing in the National Register of Historic Places. Project work must meet the [Secretary of the Interior’s Standards for Rehabilitation](#). January 17, 2024 The National Park Service’s [Historically Black Colleges & Universities Grant Program](#) (HBCU) is now accepting applications for FY2023 competitive grants. HBCU grants are funded by the Historic Preservation Fund (HPF), administered by the NPS, and fund a broad range of pre-preservation planning activities and physical preservation work for historic sites that are listed in or eligible for listing in the [National Register of Historic Places](#) or as a [National Historic Landmark](#). Congress has appropriated \$11 million for the

NEW February 1, 2024 Richland County Historic Preservation and Natural Resource Grants. Beginning Friday, December 1, nonprofits, neighborhood organizations, governmental agencies, commercial entities and other institutions can apply for Historic Preservation and Natural Resource Grants through the Richland County Conservation Commission. Both grants require a 20 percent match by the grantee.

- [Historic Preservation Grant](#): Up to \$50,000 to help preserve or restore historic buildings and cemeteries, or for educational and research projects promoting Richland County history
- [Natural Resource Grant](#): Up to \$20,000 for building trails, water quality improvement projects, green infrastructure and environmental education programs
