# 2,000<sup>th</sup> Historical Marker Dedicated at Finley High School

The South Carolina Department of Archives & History is proud to announce the dedication of South Carolina's 2,000<sup>th</sup> state historical marker on Friday, October 18, 2024. The marker honors Finley High School in recognition of the school's long service as an African American public school in Chester during segregation. Governor Henry McMaster helped mark the occasion along with state and local elected officials and members of the S.L. Finley Restoration Association. "We need to do more of this," Gov. Henry McMaster said during Friday's ceremony. "That's why we need to cover this state, to remind us and teach these

young people that spectacular things happened here. There's no place that has as much, as deep, as consequential history as this place."



### Online Map of Charleston's Burial Grounds

The Preservation Society of Charleston (PSC) in partnership with the Anson Street African Burial Ground Project (ASABG) recently released the first comprehensive map of burial grounds in the City of Charleston, a project funded by a grant from the National Park Service. The map documents 200 burial grounds, 75% of which are likely the final resting places of Black Charlestonians. Content was created utilizing existing a variety of sources, including GIS data from the City of Charleston, Charleston County, and Berkeley County, the Chicora Foundation's 2010 report, *The Silence of the Dead: Giving Charleston Cemeteries a Voice*, as well as community input facilitated by PSC and ASABG from 2022-2024.
