New State Historic Preservation State Grant Fund

The South Carolina Department of Archives & History is pleased to announce that the new Historic Preservation State Grant Fund is now accepting applications. The purpose of the State Grant Fund is to support historic preservation projects that benefit local communities through the physical repair and rehabilitation of South Carolina's historic buildings. Eligible applicants are nonprofit organizations and institutions, local governments, and federal or state recognized Native American tribes.

Grants ranging from \$40,000 to \$200,000 will be awarded for the stabilization and weatherization of historic buildings. A minimum 20% cash match of the Total Project Cost is required. Buildings must be listed as a contributing resource in a National Register of Historic Places historic district or individually listed in or eligible for listing in the National Register of Historic Places. Project work must meet the Secretary of the Interior's Standards for Rehabilitation. The application deadline for the 2023 applications is 5:00 PM on January 31, 2023. Interactive Map of Approved South Carolina Historical Markers

Check out the map of all approved South Carolina historical markers. Scroll to the <u>bottom of this page</u> and click on the map or text link. The map shows the location of all markers, and also includes subject-based filters for markers that highlight associations with African Americans, Native Americans, Women, Era of the American Revolution, Civil War, Reconstruction and World Wars I and II. Please note that recently approved markers may not yet be erected.

Tax Credit Spotlight

Located within the Rockville Historic District along the Wadmalaw River, this month's spotlight is a two-story vernacular, wood-frame house built around 1835. Prior to applying for the historic rehabilitation tax credit, the current owners began to elevate the residence; during its lift, structural deficiencies and damage to interior finishes were observed. In 2020, seeking financial assistance for the rehabilitation, the current owners applied for the 25% State Historic Rehabilitation Tax Credit. Although elevating a historic residence is not an eligible rehabilitation expense for the tax credit, SHPO certification required that the cumulative effect of the rehabilitation, including work not eligible for the credit, be consistent with the *Secretary of the Interior's Standards for Rehabilitation*. The elevation of this historic residence met the Standards because of the retention of the historic porch staircase's form and design; the introduction of screening vegetation around the structure's foundation, porch, and staircase; and the differentiated but compatible new foundation structure

materials and design. The rehabilitation included structural repairs to beams and floor joists, restoration of plaster and woodwork, rehabilitation of the chimney, and upgrades to the mechanical, electrical, and plumbing utilities. This rehabilitation balanced a project with a wide scope of work and met the Secretary of the Interior's Standards for Rehabilitation. In 2020, the SHPO certified the completed work, earning the current owners the state income tax credit equal to 25% of eligible rehabilitation expenses. Report on the Economic Impact of the Historic Tax Credit for Fiscal Year 2021 Released

Technical Preservation Services (TPS), National Park Service, has released the *Annual Report on the Economic Impact of the Historic Tax Credit for Fiscal Year 2021*. The report highlights the annual positive economic impacts resulting from the Federal Historic Tax Credit and includes information on the cumulative economic impacts since the certification of the first completed rehabilitation project in 1978. In FY 2021, the federal credit generated \$7.7 billion in GDP and 135,000 jobs. The report is available as a PDF on this website.

Grant Application Deadlines

November 8, 2022 African American Civil Rights (AACR) Grant Program. Administered by the National Park Service, the goal of the African American Civil Rights grant program is to preserve and protect sites associated with the struggle for equality from the transatlantic slave trade forward. AACR Grants fund a broad range of preservation projects including physical preservation of historic structures, National Register nominations, oral histories, education, pre-preservation planning, and more. Congress has appropriated \$21.7 million for the program in FY2022. The AACR History grant opportunity number is P22AS00647. The AACR Preservation grant opportunity number is P22AS00648.

November 9, 2022 The SC American Revolution Sestercentennial Commission (SC250) is now accepting applications for the FY 2022-2023 grants (see SC250 Grants Overview). This fiscal year, SC250 also officially launches the following competitive grant programs: (click on the grant type for details): Museum Style Panel Grants, Local Activities Grants, County Asset Assessment & Tourism Plan Grants, Research Grants, Publication Grants, Signage & Marker Grants, Site Grants: Planning, Acquisition, Development, and Renovation. All grants must be applied for through the Discover SC WebGrants program portal. Click here for step-by-step registration instructions. Competitive grants will be reviewed quarterly. Upcoming deadlines: Q2: 11/9/22 at 3:00 PM, Q3: 2/9/23 at 3:00 PM, Q4: 5/9/23 at 3:00 PM.

December 20, 2022 The National Park Service is now accepting applications for the Save America's Treasures (SAT) grant program. The SAT program provides preservation and conservation assistance to nationally significant historic sites and collections. \$26.5 million will be competitively awarded. A dollar-for-dollar, non-Federal match, is required, this can be either cash or documented in-kind services. SAT is administered by the National Park Service (NPS) in partnership with the National Endowment for the Arts (NEA), the National Endowment for the Humanities (NEH), and the Institute of Museum and Library Services (IMLS). Preservation projects fund physical preservation of historic buildings, sites, structures, and objects. Collection projects include conservation of artifacts, museum collections, documents, sculptures, and works of art. Applications are due December 20, 2022. NEW January 10, 2023 Historically Black Colleges & Universities Grant Program. The National Park Service is now accepting applications for the FY2022 Historically Black Colleges & Universities Grant Program (HBCU). HBCU competitive grants are funded by the Historic Preservation Fund (HPF), administered by the NPS, and fund a broad range of pre-preservation planning activities and physical preservation work for historic sites that are listed in or eligible for listing in the National Register of Historic Places or as a National Historic Landmark. Congress has appropriated \$10 million for the HBCU Grant Program. NEW January 31, 2023 Historic Preservation State Grant Fund. Administered by the SC Department of Archives and History, this new state-funded grant program will award grants ranging from \$40,000 to \$200,000 for the stabilization and weatherization of historic buildings in South Carolina. Eligible applications are nonprofit organizations and institutions, local governments, and federal or state recognized Native American tribes. A minimum 20% cash match of the Total Project Cost is required. Open for Applications, USDA - Rural Development Community Facilities Direct Loan & Grants. This program provides affordable funding to develop essential community facilities in rural areas.
