The purpose of the State Grant Fund is to support historic preservation projects that benefit local communities through the physical repair and rehabilitation of South Carolina's historic buildings. This year applicants may apply for either a **Planning Grant** to develop "bid-ready" plans and specifications OR a **Stabilization Grant** to assist with historic building stabilization and weatherization projects. 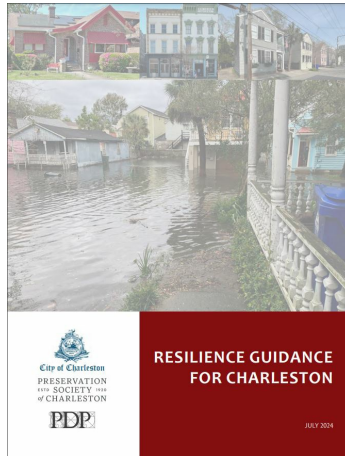
### Tax Credit Spotlight



This month's spotlight features a c. 1867, three-story brick building in the Charleston Historic District. Historically the building's ground level was commercial space and the upper floors were residential spaces. With a private investment of \$3.6 million that earned the applicant \$720,000 in Federal income tax credits and \$900,000 in State income tax credits, the historic building's upper floors were rehabilitated into multi-use coworking space and the ground floor was provided a "whitebox" condition ready for a tenant to upfit. The project repointed the exterior masonry, repaired windows and replaced windows that were severely deteriorated beyond repair, rehabilitated the piazza, replaced the roof, restored fireplaces, upgraded the MEP systems and fire protection systems, and rehabilitated interior finishes. The applicant states, "City House is proud to be a part of another historic restoration, our first in South Carolina. We look forward to continuing our presence in Charleston..." 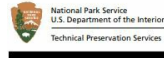

#### Building Codes for Historic and Existing Buildings: Planning and Maximizing their Application

## Upcoming FY 2024 Funding Opportunities from NPS

The National Park Service will soon open three funding opportunities for the Save America's Treasures, Semiquincentennial, and Paul Bruhn Historic Revitalization grants programs.

- **Save America's Treasures** funds the physical preservation of nationally significant properties and collections. Applications for **\$25.5 million** in funding are anticipated to open in summer of 2024 and be due in fall of 2024. To be notified when the grant opportunity opens, please visit [Grants.gov](https://grants.gov) and subscribe to a saved search for CFDA number 15.929.
  - The **Semiquincentennial Grant Program** funds the restoration and preservation of sites and structures listed on the National Register of Historic Places that commemorate the founding of the nation. Applications are anticipated to open in fall of 2024 and are due in winter of 2025. Congress has appropriated **\$7 million** for this program in fiscal year 2024.   - The **Paul Bruhn Historic Revitalization Grant Program** fosters economic development in rural communities through the rehabilitation of historic buildings. The program provides recipients (referred to as prime grantees) with a single grant that is then regranted in smaller amounts to individual projects (subgrants). Congress has appropriated **\$10 million** for this program in fiscal year 2024. **NEW September 27, 2024 Municipal Association of SC Hometown Economic Development Grant**. The grants are aimed at projects that will produce measurable results that can be maintained over time and illustrate best practices. The grant is open to any SC community. Projects must be shovel-ready, and must include a full proposal that can be executed and completed within 12 months of the award (not 24 months). **September 30, 2024 T-Mobile Hometown Grant Program**.
