Historic Preservation State Grant Fund Applications: Due September 24, 2025



HISTORIC PRESERVATION STATE GRANT FUND APPLICATION

The State Historic Preservation Office is now accepting applications for the Historic Preservation State Grant Fund for FY 25-26. The purpose of the State Grant Fund is to support historic preservation projects that benefit local communities through the physical repair and rehabilitation of South Carolina's historic buildings.

This year applicants may apply for either a **Planning Grant** to develop "bid-ready" plans and specifications OR a **Stabilization Grant** to assist with historic building stabilization and weatherization projects.

Tax Credit Spotlight

This month's spotlight features a c. 1882 two-story, brick commercial building on Abbeville's historic Court Square. Between 2021 and 2024, this rehabilitation revived a vacant building and continued its historic use with new retail on the ground floor and added apartments on the upper floor. The project retained character-defining features including its two types of facade windows (indicative of the two historic tenants who each occupied one of the building's two storefronts), fireplaces, cornices, mosaic tiles, hardwood flooring, and pressed metal ceilings. The pressed metal ceilings were sensitively removed, cleaned, and reinstalled to abate lead as well as provide a fire separation between the tenants and different uses on the first and second floors. Compatible treatments also included retaining the altered storefront, repainting the already painted masonry, reconfiguring vertical circulation in secondary spaces, adding new signage and new sitework.



The applicant, Joe John said, "Rehabilitating the P.D. Speed's building was an opportunity to create a unique residential product as an example of the vision I have for Abbeville's historic district. The State and Federal tax credit programs were the critical element that enabled uncompromised standards with a reasonable financial model."

An Endangered Places Program Initiative

Preservation SC's <u>Endangered Places Program</u> was created in 1996 as a part of the organization's initiative to support historic preservation in communities across South Carolina. The program was created to save threatened historic buildings, usually by getting the right to purchase the properties, then selling them to people who agree to restore them. To date, more than 40 properties have been protected by the program. The program is made up of two components: the Endangered Places Revolving Fund, and Endangered Places Advocacy.

The Endangered Historic Property Form is a part of the Endangered Places Advocacy component of the Program. The purpose of this form is to identify vulnerable historic properties for potential investment, while advocating and encouraging for their preservation. Preservation South Carolina asks, "Do you know of an endangered historic property that has not received the attention it deserves? Forms are accepted on a rolling basis throughout the year. We will reply to your submission within 60 days."

New NPS Guidance on Historic Wood Flooring and Substitute Materials

The National Park Service has issued <u>new guidance</u> that provides information about evaluating historic wood flooring for possible replacement and when it may be acceptable to use a different material than the historic one for replacement consistent with the Standards for Rehabilitation. Substitute materials addressed include engineered wood and Luxury Vinyl Tile (LVT)/Luxury Vinyl Plank (LVP). The principles discussed in this guidance can also generally be applied to the replacement of other types of flooring materials beyond just wood. September 30, 2025 T-Mobile Hometown Grant Program. Main Street America and Smart Growth America have partnered with T-Mobile to help build stronger, more prosperous small towns and rural communities. T-Mobile's Hometown Grant program awards up to 100 towns a year with project funding for a wide range of community development projects like upgrading tech at local libraries, building new hiking trails and revitalizing historic buildings. NEW October 1, 2025 National Trust Preservation Funds. These grants are intended to encourage preservation at the local level by supporting on-going preservation work and by providing seed money for preservation projects. With funds ranging up to \$5,000 these grants help stimulate public discussion, enable local groups to gain the technical expertise needed for preservation projects, introduce the public to preservation concepts and techniques, and encourage financial participation by the private sector.
