**Section 106 Applicant Toolkit:** The Section 106 Applicant Toolkit provides guidance on the steps necessary to fulfill the requirements of Section 106 of the National

Historic Preservation Act to those who apply for federal licenses, permits, funding, or approvals. Many federal agencies now require applicants to assist them in compliance with Section 106, so these tools will help applicants better engage in Section 106 reviews and support timely reviews. The toolkit includes an overview of the Section 106 requirements and step by step guidance on supporting consultation with states and Indian tribes, engaging stakeholders, and avoiding inadvertent activities that may adversely affect historic properties. ### 3. Guidance on Recording Cemeteries

The SC SHPO has created guidelines for recording historic cemeteries. This guidance describes when a cemetery should be recorded as an above-ground resource and when to record as an archaeological site.
