### So, how do we help?

- Consultation indirect and direct
- On site analysis
  - Various search techniques including geophysics.
    - Ground Penetrating Radar, Bartington Gradiometer, Earth Resistivity, and drone photogrammetry.
- Excavation (under special circumstances)
- Fair witness to facts
- Professional opinion



### **Search and Geophysics**

- Sometimes, no equipment is necessary.
- Subsidence occurs naturally as soils settle, coffins decay, vaults crumble, or can be accelerated – as in this instance – by torrential rains.

The features are usually much more subtle.

- Not all search techniques require expensive equipment or extensive training.
- For instance, \$12 tile probes can be very effective.






### Search and Geophysics Earth Resistivity RM4




### Search and Geophysics Bartington Gradiometer

- 20m x 20m survey area
- Unmarked burial ground in use since 18<sup>th</sup> c.
- Property had been repurposed as a park
- Descendants were convinced their loved ones were still there.
- They were correct.

- 1. What is your name and contact information?
- 2. How are you involved with the issue?
  - Are you a descendant? Neighbor? Or \_\_\_\_\_?
- 3. Is the burial/cemetery under threat?
- 4. Where is it located (street address, lat/long, and/or county tax map designation)?
  - The bane of existence is a lengthy description of turning right, left or going straight after what had been the Piggly Wiggly that burned down in 1950.

Just the Facts Please.

- 5. If the burial/cemetery is under threat, briefly explain what the threat is.
  - Construction or development?
  - Borrow pit removal or dumping?
  - Looting or desecration?
  - Or?

6. Has an effort been made to contact:

• The owner, or contractor, or city/town council etc.?

7. In the case of looting or vandalism has a complaint been filed with Law enforcement?

Just the Facts Please.

- 8. Have you taken any digital photos of the issue?
  - Bless the person who put a decent camera on a cell phone...

There are additional questions, but you get the idea.

Depending on what the answers are to the questions determines the response.

- Burials and cemeteries that are under threat are a high priority.
- Descendants have stronger standing when it comes to discussions with landowners, politicians, law enforcement etc.
- Solving burial or cemetery issues are almost never quickly done.
- The use of cemeteries or burials as a NIMBY tactic rarely work.


