

## APPENDIX

### JOURNAL OF THE DIRECTORS OF THE CHEROKEE TRADE NOV. 9TH-17TH, 1762 AND JUNE 30TH, 1763 ACCORDING TO AN EARLIER COPY OF THE JOURNAL

*November 9th, 1762<sup>1</sup>*

Present at Mr. Poinset's: Thomas Lamboll, Thomas Shubrick, Gabriel Manigault, John Savage, Thomas Smith.

Ordered that a Brand-Iron with the Letters SCT be procured and paid for by Gabriel Manigault, Esq., Cashier, and forwarded by some convenient Opportunity to the Factor at Fort Prince George to brand the Necks of the Skins and Furs that shall be purchased at that Factory on account of the Public Trade.

Resolved that (pursuant to the Directions of the Act of Assembly to regulate the Trade with the Cherokee Indians &c.) the heavy Indian drest Deer Skins to be sold from Time to Time at Vendue for Account of the Publick be put up for Sale in Lots of about two hundred Skins in a Lot until it shall be otherwise resolved.

The Directors proceeded to ascertain the Quantity and Quality of the Goods to be provided and sent for supplying the Factory at Fort Prince George as soon as the same can be completed; and Mr. Savage and Mr. Smith are to purchase and provide the Assortment accordingly.

*November 15th, 1762*

Present at Mr. Poinset's: Thomas Lamboll, Gabriel Manigault, John Savage, Thomas Smith.

Received and agreed to the Proposals of Thomas Nightingale, and resolved to employ his Waggons and Horses on the present Occasion to carry up an Assortment of Goods for the Publick Trade and Necessaries for the Factory at Fort Prince George Keowee, at four Pounds per hundred Weight when safely delivered; and forty Pounds per Load (of Skins, Furs &c.) of fifteen hundred [Weight] to be brought down from thence and safely delivered in Charles Town to the Directors on Account and Risque of the Publick.

Agreed upon the Rates and Prices of certain additional Articles and Goods now providing to be sent to the Factory at Fort Prince George for Sale to the Cherokee Indians.

*November 17th, 1762*

Present near the Bay of Charles Town: Thomas Lamboll, Thomas Shubrick, Gabriel Manigault, John Savage, Thomas Smith.

<sup>1</sup> A comparison of the proceedings of November 9th-17th printed here with those on p. 519 above will show that the copy of the Journal used in printing this volume skips the proceedings of the 9th (after listing the Directors present on that date) to the paragraph beginning with the words "Who proceeded . . ." on the 17th.

Who proceeded to expose to Sale at Vendue for ready Money and did sell one thousand two hundred thirty-four dressed Deer Skins and two Bever Skins, and deliver the same to the highest Bidders; amounting to one thousand five hundred twenty-seven Pounds, eight Shillings and nine Pence current Money as per Account of Sales.

Ordered that Gabriel Manigault, Esq., Cashier, do pay and defray the Charges already accrued for a Crier to call out the Skins and for weighing the same this Day sold at Vendue, to the highest Bidders; and likewise all Charges of the like Kind, which shall hereafter accrue on selling Skins and Furrs belonging to the Publick Indian Trade according to Law.

*June 30th, 1763<sup>2</sup>*

Present at Mr. Smith's: Thomas Lamboll, Thomas Shubrick, Gabriel Manigault, John Savage, Thomas Smith.

Ordered, That Gabriel Manigault, Esq., Cashier, do pay unto Thomas Smith, Esq. or Order the Sum of nine hundred ninety-three Pounds, four Shillings and two Pence, current Money, for sundry Goods, Merchandize and Utensils (with Charges) bought and received of him for the Use of the Publick Indian Trade as per Bill of Parcels.

Also unto Mr. John Gordon or Order the Sum of three Pounds, seven Shillings and six Pence, current Money, Balance due to him on fifteen Peeces of Bristol striped Strouds received in Exchange for ten Peeces of London Strouds, as per Bill of Parcels for the Publick Cherokee Trade.

Also unto Mr. James Laurens and Company, or Order, the Sum of forty-three Pounds, fifteen Shillings, current Money, for five hundred Weight of leaden Bullets bought and received of them for the Publick Cherokee Indian Trade, as per Bill of Parcels.

Also unto John Savage, Esq., or Order the Sum of fifty-eight Pounds, eight Shillings and nine Pence current Money for two Barrels Muscovado Sugar bought and received of him for the Use of the Publick Cherokee Indian Trade, as per Bill of Parcels.

<sup>2</sup>The proceedings of this date printed on pp. 530-31 above omit the paragraph beginning with the words "Also unto Mr. James Laurens and Company . . ." and begin the last paragraph with the words "Also unto Mr. Thomas Lawrence [*sic*] and Company. . . ." The clerk making the copy confused the two accounts, referred to James Laurens as Thomas and ascribed Savage's account to Laurens.
